The Hilux Club (hereafter referred to as the "Club") grants you, as a member of the Club, authorization to operate your VHF radio on Club frequencies, provided that:

1. Your membership of the Hilux Club must be fully paid and valid for the current membership year.
2. Your VHF radio must be type-approved by ICASA for operation on the Commercial Band frequencies. Amateur Band (Ham) radios are not so licenced and may not be used for purposes of VHF Commercial frequency operation. You are obliged to advise the Club of Make and Model number of your radio/s, we do not require serial numbers. Please do so here:

Complete all fields by typing directly into each field. If you do not know the serial number, simply enter the radio model number again. You will then be allocated a call sign number commencing "HC....".

3. The license authorization is not transferable if/when you sell either your vehicle or the radio, the Hilux Club Administrator (radios@hiluxclub.co.za) should be advised of this in writing. The VHF permit is issued in your name only, in accordance with ICASA regulations.
4. The Club will not charge any fees for the Club Frequency but reserves the right to do so should ICASA adjust the Club's Annual licence fees at any time in the future. Your membership of the Hilux Club must at all times be fully paid up in order to validate the VHF Permit.
5. It should be realized that the Club frequencies allocated to us by ICASA are not unique to us as a Club and there may well be other co-users sharing the frequency. Please respect this at all times.
6. The Club frequency is for the benefit of the Hilux Club members only and not to general forum members. Anyone having a two-way radio is encouraged to join the Club and therefore benefit from this privilege. The Club frequencies are valid only within the borders of South Africa and not the surrounding States.
7. The Club radio frequencies are intended for bona-fides Club members only and may not be used for any means of Business communication, for which you require your own private licence.
